- 1. Box A Voter information All information must be provided in this section. Be sure to clearly print or type.
- **2. Box B Address where ballot is to be sent -** If receiving your ballot at an address other than the one listed in Box A, this section must be completed.
- 3. Box C Mail ballot categories There are 4 categories to choose from in this section. Check the category that applies to you. If the address you are having your ballot mailed to is different than the address in Box A, you must provide that address in Box B.
- **4. Box D Oath of voter and signature -** You must read the oath of voter in this section. You must then sign your name in full attesting to the oath. Your signature does not need to be witnessed or notarized.
- **5. Return your completed application -** Return your completed application to "Board of Canvassers" in your city/town listed below.
