- » Your application is a matter of public record, but your vote is confidential.

- 1. Box A Voter information All information must be provided in this section. Be sure to clearly print or type.
- **2. Box B Address where ballot is to be sent -** If receiving your ballot at an address other than the one listed in Box A, this section must be completed.
