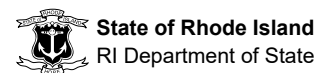

NOTICE TO APPLICANT

- If anyone attempts to intimidate or unduly influence you, or interfere with your right to vote, contact your Local Board of Canvassers.
- Any person knowingly and willfully making a false application or certification or knowingly and willfully aiding and abetting in the making of a false application or certification shall be guilty of a felony and shall be subject to the penalties provided for in section 17-26-1, [RIGL 17-20-8(D)].
- Your application is a matter of public record, but your vote is confidential.

Instructions - Be sure to clearly print or type.

1. **Unaffiliated voters must choose a party** to receive a mail ballot in a primary election.
2. **Box A (Your information) and Box B (Address where your mail ballot is to be sent)** - All information must be provided in these sections. If you want your mail ballot sent to a mailing address, you must provide that address in Box B.
3. **Box C (Mail ballot categories)** - Check the category that applies to you. If the address you are having your mail ballot sent to is different than the address in Box A, you must provide that address in Box B.
4. **Box D (Voter's oath and signature)** - You must read the oath of voter and sign your name in full attesting to the oath.
5. **Signature** - The registered voter requesting the mail ballot must sign this application. If voter is unable to sign their name this application must be signed and attested to by the Voter Assistant.
6. **Return your completed application** - Return your completed application to the "Board of Canvassers" in your city/town listed below.
7. **Track your mail ballot** - Visit vote.ri.gov to sign up for *Ballotrax*. You will receive notifications on the status of your mail ballot application and mail ballot delivery information. Mail ballots are sent to voters approximately 3 - 4 weeks before the election. **Election mail cannot be forwarded. Be sure to carefully check the address where you want your mail ballot sent.**
8. **Receiving your mail ballot** - Your mail ballot packet will have your ballot, instructions, voter's certificate and the required postage-paid envelope to return your voted ballot to the State Board of Elections.
