# Continued From Previous Column

Sec. 305. - Conduct of Meetings. The Town Moderator shall have all of the authority conferred upon moderators by state law in conducting and managing the business of town meetings. Pursuant to the State open meetings law, the Moderator shall grant permission for the admission of persons who are not electors of the Town; provided, however, that all such persons shall be seated in an assigned area apart from the seating for the electors of the Town, and such persons shall have no right to vote. Such persons shall also have no right to speak except with the specific permission of the Moderator.

Sec. 307. - Quorums for Meetings. (a) A quorum for any Town financial or special meeting shall be fifty (50) electors of the Town of Exeter. In the event that, for any reason, a quorum is not present at the time a meeting is scheduled to open the Town Moderator, or if not present the Town Clerk, is authorized to delay the opening time of the meeting by no more than one hour. (b) If the meeting quorum is not met before one hour has lapsed, the Town Moderator, or if not present the Town Moderator, or if not present the Town Clerk, shall announce that due to the lack of a quorum, the meeting cannot be called to order. (c) Whenever any scheduled meeting lacks a quorum, any and all budgets, budget line items, and resolutions previously posted and copied pursuant to Section 304 and published in summary form pursuant to Section 503 and presented by the Town Council for the scheduled meeting shall be made a part of the record and shall be deemed approved by default and any and all proposals for expenditure outside of those that the Council presented, shall be deemed unapproved and rejected by default.

#### **Rationale**

The Town's Charter does not address or provide any guidance or procedures for when a quorum is not met at the annual or special Financial Town Meetings (FTM). With the steady decline in voter attendance at the FTM and increased demands from the State for budget information and pre-adoption approvals, the Town Council believes that if, or when, this occurs it could significantly impact the Town financially and limit the ability to provide services to the residents of Exeter.
